



Contest Rules and Waiver of Liability

These Rules and Waiver apply to ALL contests held at Peavey Mart or MainStreet Hardware stores.

By entering any contest at a Peavey Mart or MainStreet Hardware, contest entrants acknowledge they have read these rules and waiver.

1. **Contest Sponsor:** Peavey Industries LP, 7740-40 Ave Red Deer, AB T4R 2H9
2. **Eligibility:** Contest is open only to Canadian residents who are 18 years of age or older at time of entry, except employees, representatives and agents of the Contest Sponsor, its affiliates and their respective advertising and marketing agencies, Contest administrators, judges and persons domiciled with any of the above. This contest is not valid in the Province of Quebec.
3. **Agreement to Official Contest Rules:** By participating in the Contest, you fully and unconditionally agree to and accept the Official Contest Rules and the decisions of the Contest Sponsor and its Contest administrators and judges, which are final and binding in all matters related to the Contest.

5. **Digital Entries:** Online and e-mail entries must be made only by the original, manual keystrokes of the individual entrant. Use of any automated system including robotic or form filling software to enter or participate is prohibited and will result in disqualification of all entries by anyone using such assistance.
6. **Disqualification:** The Contest Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Contest Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Contest Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Contest Sponsor's failure to enforce any term of these Official Contest Rules shall not constitute a waiver of that provision.
7. **Odds Of Winning:** The odds of winning will depend on the total number of eligible entries received during the Contest Period. All entries must be received during the Contest Period. All entries and prize claims are subject to verification by Contest Sponsor and will be void if not obtained through legitimate channels, or if not original, or if obtained other than in compliance with these Official Contest Rules. The Contest Sponsor will not accept screen shots or other evidence of winning or entry in lieu of its verification process. Proof of sending is not proof of receipt. All entries become the property of the Contest Sponsor and will not be returned.

9. **Winning the Contest - Selected Entrant:** In order to be declared a winner, selected entrant must first correctly answer, unaided, a time-limited mathematical skill-testing question to be administered at a pre-arranged time by telephone and otherwise comply with the Official Contest Rules. The Contest Sponsor or its representatives will make reasonable attempts to contact the selected entrant at the e-mail address and/or telephone number(s) recorded in respect of his/her Collector Number and/or indicated on the e-mail entry, as the case may be. If a selected entrant cannot be contacted or has not responded within **three (3) days of the date when contact was first attempted**, is not eligible in accordance with these Official Contest Rules, does not correctly answer the mathematical skill-testing question or otherwise comply with these Official Contest Rules, then the selected entrant is disqualified and will not receive the Prize and another entrant may be selected. A selected entrant must sign and return to the Contest Sponsor within **three (3) days of receipt** this Peavey Contest Rules and Waiver, signed by the Selected Entrant in order to be awarded the Prize. 10. **Travel:** If the contest includes any form of travel, the Prize Winner acknowledges that travel insurance for missed flights or any illness is not included. The guest of the Prize winner (and his/her parent or legal guardian if a guest is under the age of majority in his/her jurisdiction) must also sign a release to participate in the Prize. Winner and his/her guest must originate at the same airport travel on the same itinerary for both the outbound and inbound flights. Travel will originate from the major Canadian airport closest to the winner's residence as determined by Contest Sponsor in its sole discretion. Winner and his/her guest are responsible for arranging and obtaining all necessary international travel documentation (e.g. passports, VISAs, etc.), as required. No changes to travel dates or passenger names are permitted once a booking has been confirmed. Winner and his/her guest are responsible for transportation to and from the Canadian airport and all other expenses not stated as included herein.  - a. The confirmed Winner and his/her guest must have the legal right to leave Canada and to return to Canada and must have the legal right to enter and leave the destination country to which they are bound. They are fully responsible for obtaining, at their own expense, all documentation necessary for the trip as required by the authorities concerned, including, but not limited to, visas, passports, vaccinations and certificates. These shall be obtained before departure.
 - b. All international travel documentation that may be required (visa, passports, etc.) are the confirmed Winner's and his/her guest's responsibility and must be obtained prior to departure. Passports for all travelers must be valid for a minimum of 6 months from the date of departure. No changes to travel dates or passenger names are permitted once a booking has been confirmed.
 - c. It is strongly recommended that travel insurance be purchased by the winner and his/her guest at time of reservation as a measure of added protection.
 - d.
